

Estimated School Bond Debt Taxes Under Current Law and Gov and Senate DSE Proposals

The attached printout shows estimated general school debt service property taxes on selected properties under current law and the Governor and Senate proposals for Debt Service Equalization (DSE). The tax amounts shown are estimated, but should provide a reasonable approximation of the change in school general debt service taxes that would result under these proposals relative to current law.

Restoring debt service equalization was recommendation #2 of the 2013-14 School Facilities Financing Working Group. Several of the working group recommendations have been enacted by previous legislatures including Long Term Facility Maintenance (LTFM) funding and enhanced equalization for any district which experiences a natural disaster.

The Working Group's Rationale for this recommendation is still valid: "The state share of debt service revenue has declined from 11.3 percent in FY 1995 to 3.1 percent in FY 2015. Currently, 80 percent of all debt service revenue is below the threshold to qualify for equalization, and the equalizing factor for Tier 1 equalization is so low that only 7 percent of the state's students are in districts where the tax base per student is low enough to qualify for Tier 1 equalization aid. A stronger state commitment to debt service equalization is needed to ensure that all districts have access to adequate, equitable and sustainable funding for major facilities projects regardless of local tax base."

These proposals are a long way from restoring DSE and show what can be done from two different perspectives

- The Governor's proposal focuses on districts with high debt service levies with reductions in the Tier II equalizaton factor from 26.2% to 22.3% in Pay '18 and 19% for Pay 19 and beyond
- The Senate proposal reduces the Tier I threshold from 15% to 10% and increases the Tier I equalization factor to 75% of Average ANTC for Pay '18 only.
- Both proposals use ANTC, not modified ANTC (with Ag valued at 50%) which is used for LTFM equalization calculations.
- Neither proposal indexes equalization to average ANTC.

Description of columns in printout:

- **Total Tax Capacity (Net).** Total taxable tax capacity after subtracting fiscal disparity contribution, captured tax increment, and excluded power line tax capacity and adding fiscal disparity distribution tax capacity, based on the 2015 assessment (corresponding to taxes payable in 2016).
- **Current Law Debt Levy.** Projected current law school general debt service levy for taxes payable in 2018.
- **Current Law Debt Tax Rate.** Estimated current law school general debt service tax rate, calculated by dividing "current law debt levy" by "total tax capacity (net)."
- **Proposed Governor Debt Tax Rate.** Estimated proposed school general debt service tax rate, calculated by dividing "current law debt levy" minus "Governor aggregate DSE tax relief" by "total tax capacity (net)."
- **Debt Tax on a \$200,000 Homestead Under Current Law.** Estimated school general debt tax under current law for a residential homestead with a \$200,000 market value.
- **Debt Tax on a \$200,000 Homestead with Governor's proposal.** Estimated school general debt tax under proposed DSE for a residential homestead with a \$200,000 market value.
- **Debt Tax on \$200,000 Homestead: Difference.** Difference between estimated debt tax under current versus Governor's proposed DSE on \$200,000 homestead.
- **Proposed Senate Debt Tax Rate.** Estimated proposed school general debt service tax rate, calculated by dividing "current law debt levy" minus "Senate aggregate DSE tax relief" by "total tax capacity (net)."
- **Debt Tax on a \$200,000 Homestead Under Current Law.** Estimated school general debt tax under current law for a residential homestead with a \$200,000 market value.
- **Debt Tax on a \$200,000 Homestead with Senate's proposal.** Estimated school general debt tax under proposed DSE for a residential homestead with a \$200,000 market value.
- **Debt Tax on \$200,000 Homestead: Difference.** Difference between estimated debt tax under current versus Senate's proposed DSE on \$200,000 homestead.
